## WE NEED YOUR HELP TO PROTECT THE BAY

animals that live in both salt water and fresh water.

# YOU CAN HELP PROTECT The Bay From Permethrin!

#### **1.** AVOID PRODUCTS ENDING IN "THRIN"

Make sure you look in the "active ingredients" and avoid products ending in "thrin." They belong to a class of pesticides called pyrethroids and are a threat to water quality, and highly toxic to aquatic insects and crustaceans.

# **2.** DO NOT DISPOSE OF PERMETHRIN DOWN THE DRAIN

Due to high toxicity for aquatic life, permethrin should be disposed of at a hazardous waste collection facility such as Marin Sanitary Service.

There are over 1,400 products with permethrin in the form of liquids, powders, dusts, aerosols, sprays, treated clothing, pet flea collars and spot-on treatments.

# AVOID PERMETHRIN: Though Commonly Found in Pet and Household Pest Control Products, It Gets into the Bay and is Killing Aquatic Life



Permethrin is dangerously toxic to cats and aquatic life.

#### WHAT IS PERMETHRIN?

Permethrin is a synthetic chemical, widely used as an insecticide and insect repellent on landscaping, as a flea preventive treatment for pets, on humans to eradicate parasites such as head lice and scabies, and for other similar uses.

#### WHAT PRODUCTS CONTAIN PERMETHRIN?

Products containing permethrin may be liquids, powders, dusts, aerosols, sprays, treated clothing, and pet flea collars and spot-on treatment. There are more than 1,400 registered products containing permethrin.

#### **HOW DOES PERMETHIN WORK?**

Permethrin affects the nervous system in insects, leading to death. It is also dangerously toxic to cats and aquatic life. It is not acutely toxic to humans and birds, but the EPA classifies it as a likely human carcinogen.

#### HOW DOES PERMETHRIN AFFECT THE ENVIRONMENT?

When permethrin gets into the Bay, it binds to sediment and can stay there for more than a year. Permethrin is highly toxic at extremely low levels to fish and other animals that live in either salt water or fresh water. It can kill aquatic life at levels as low as onebillionth of a gram per liter.

# Please Limit or Avoid Permethrin Use

- **1.** Make sure you **LOOK IN THE "ACTIVE INGREDIENTS"** and avoid products ending in "thrin". The exception to this is pyrethrin, which is produced naturally from the chrysanthemum flower.
- **2. DO NOT** dispose of permethrin down the drain. Take permethrin products to a hazardous waste collection facility, such as Marin Sanitary Service.
- **3. USE LESS TOXIC ALTERNATIVES**

#### HOW TO DISPOSE OF HOUSEHOLD HAZARDOUS WASTE

Wastewater treatment plants are not designed to remove hazardous waste and other chemicals.

#### DUMPING CAT LITTER DOWN THE DRAIN KILLS SEA MAMMALS!

A deadly parasite in cat feces can survive sewage treatment and make its way to the Bay.

**Don't Dump Cat Litter Down the Drain.** Not only does it clog drains leading to spills and blockages—it harms sea mammals. Cat feces can contain a parasite, toxoplasma gondii, which is linked to the death of sea otters, whales and porpoises.

The ONLY safe way to dispose of cat litter is by putting it in the garbage.

# KEEP FATS, OILS AND GREASE (FOG) OUT OF SINKS **PREVENT CLOGS AND OVERFLOWS!**

Never pour fats, oils or grease down the drain. Even with hot water, the grease builds up inside pipelines over time. Also, avoid putting fatty food scraps down the disposal.

#### **RECOMMENDED GREASE CONTROL PRACTICES**

- Collect fats, oils and grease into a container and dispose in the garbage.
- Dry-wipe pots and pans containing grease with paper towels before washing.
- Scrape food scraps into the garbage or compost bin.

You can care for your pet, your home and the environment without using permethrin based insecticides.

Below is a list of less toxic alternatives you can try.

- Frontline, Advantage and Program are examples of anti-flea chemicals that **DO NOT** contain permethrin
- Concern Crawling Insect Killer
- Fleanix
- Saver Crawling Insect Killer
- Oil of eucalyptus
- Neem oil
- Catnip
- Boric acid
- Essential oils such as citronella, basil, clove and rosemary
