


McInnis Marsh Restoration Project

McInnis Marsh Location Map








MCINNIS MARSH HISTORIC BAYLANDS (1914)










MCINNIS MARSH FLOOD ELEVATIONS






MCINNIS MARSH EXISTING VEGETATION






MCINNIS MARSH CUT AND FILL






MCINNIS MARSH LEVEE/BERM CROSS-SECTIONS

Background:

The Collections Department has been operating without the use of a vacuum/flusher combination unit since the 1992 *Vactor 2103* was deemed irreparable in early 2015. Budgetary reallocations prevented procurement of a new vacuum/flusher combo unit until the fiscal year 18/19 budget was approved. A vacuum/flusher truck is crucial to the District's ability to properly perform the day-to-day maintenance of the Collection System but more importantly, it is vital in the response to and cleanup of sewer system overflows.

After evaluating the (2) primary manufacturers of combination vacuum/flusher vehicles, *Vactor* and *Vac-Con*, based on the District's needs, Class C Driver's License limitations, vendor responsiveness and service reputation, staff recommends proceeding with the purchase of a 3.5 yard *Vac-Con*. The District can purchase a 2018 Vac-Con Model V230H/500 on a Freightliner 108SD chassis for \$305,844.19; this cost includes sales tax and delivery. The purchase is available through the National Joint Powers Alliance Contract (NJPA) cooperative purchasing program.

Staff did enquire about a CNG powered chassis. Due to the heavier Gross Vehicle Weight Rating of the standard components of a vacuum/flusher combination truck and the absence of space required to mount CNG fuel tanks, CNG is not available.

Staff Recommendation:

Board to approve the purchase of the 2019 *VaCon* Vacuum Combination truck through the NJPA cooperative purchasing program.

Vac-Con CNG Option

Good morning Greg,

I did a little research and it appears Freightliner does not have a CNG option for the 108SD chassis which I have quoted you on the Vac-Con. Because the unit must be a Class C vehicle, the Freightliner 108SD is the recommended chassis by the factory with the required horsepower needed to run the water pump and two-stage vacuum system. Also, because the wheelbase of this unit is so short, there simply wouldn't be enough room to house the CNG fuel tanks that would be mounted behind the cab.

The only options for CNG provided by Freightliner is the M2 112 which is on the PipeHunter and the 114SD. The 114SD has a GVW of 65,000lbs making it a Class B vehicle and the M2 112 doesn't have the necessary horsepower to drive both the water pump and Vacuum system.

Bottom line, the Freightliner 108SD is the correct chassis for this particular truck – a Class C vehicle with the necessary horsepower.

The District has used Data Instincts for public outreach and awareness services for the past four years. Mark Millan and his staff have assisted the District with press releases, drafting the newsletters, newspaper ads for public hearings related to the user charge and budgets and revamped the District's website.

During the fiscal year ending June 2018, Data Instincts developed two newsletters in order to continue informing the public about District activities. Mr. Millan and his staff have substantial experience in the wastewater and recycled water industries, which greatly benefits the District efforts to keep customers informed of District issues and activities. Staff is able to provide the Data Instincts staff with minimal direction and still receive a substantially complete product that can be finalized in an efficient manner.

Attached is a proposal from Data Instincts to perform services for the annual period of 2019. This proposal includes press releases, media relations, newsletters, and the official Proposition 218 mailer. For 2018-2019, the budgeted amount for these activities was \$21,000, but no costs have occurred as yet in this fiscal year. For 2019, they are expected to produce two newsletters, the next annual legal notices for rate increases, as well as public outreach as needed. The proposed budget for the current fiscal year is \$20,000. Data Instincts is estimating the cost to be from \$20,500 to \$25,500 during this calendar year.

STAFF RECOMMENDATION:

Board to approve the contract with Data Instincts and authorize the General Manager or his designee to sign the 2019 contract.

FISCAL IMPACT:

There could be a minor financial impact of \$5,500, since this item is budgeted at \$20,000. The overage will covered by transferring unused budget amounts from other categories into this category.

Follow up on NBWA Strategic Planning Process – plan is still in draft form; should be finished this March. Handout given. Four counties including Solano now in NBWA.

Tech committee used to just be staff people; there are28 agencies now. NGO partners also at JTC as part of the work. JTC gives advice to NBWA board on variety of issues; first stop on projects that NBWA funds. Will be relying on this group even more to move the strategic vision forward. **Hoping to get staff reps from all agencies to come to this meeting in future.** Attempting to get standard day/time on bi-monthly basis.

Thinking more holistically about the resources we manage; One Water concept; regionally integrated work. Related to IRWMP. What does One Water really mean for the North Bay? Focus on projects. Treat everything as a resource. How do we get better and bigger projects built? Where do we find the funding?

Looking for JTC members to add to Strategic Plan; identify gaps.

→ Need to articulate the fish/wildlife piece in the SP of One Water. LID needs. Like the watershed by watershed approach; to see both the unique needs and priorities as well as comprehensive issues that cross watershed boundaries. → Do we need to fund a grant writing/tracking person?

BARR—Bay Area Regional Reliability project; US BuRec Bay Area regional water suppliers planning for drought/water supply. Bayareareliability.com

RCDs are looking at JPA for entire North Coast area, SF Bay to Oregon border.

4 Strategic Directions in NBWA Plan:

- Take a One Water approach. Thinking regionally as integrated water management agencies. Working collaboratively; planning long term. Trying to not be so driven by grants/funding; be more strategic. Long term capital building; infrastructure building; bond funding for N. Bay. Looking for Regional Plan development. Santa Clara Valley doing well in this regard; have them in as speaker at future meeting.
- 2. Develop Regional Projects. Identify gaps. Bay Area Joint Venture as good resource for projects/funding. NBWA did a watershed plan when it first launched; need to update this. True regional projects are hard to find/develop. Funders focus on project creativity and partnerships. Ideas:

Sewage overflow under review

The rain that pounded Marin County on Sunday overwhelmed a sewer rehabilitation project in San Anselmo and caused about 50,000 gallons of raw sewage to spill out of manholes and into storm gutters and creeks.

"The rainfall pattern on Sunday was extraordinary," said Steve Moore, general manager of the Ross Valley Sanitary District, which owns the project. "In one hour, there was almost one inch of rain, about 0.91 inches."

Moore said the sewage spill occurred Sunday afternoon along Broadmoor Avenue just north of Sir Francis Drake Boulevard, where construction workers had earlier Sunday set up a sewer bypass to "tie in" two sections of the project. The project has been ongoing since last summer and is due for completion on Jan. 18.

"They had planned to complete the tie-in on Saturday but were unable to finish, so they set up to - complete it on Sunday," Moore said of the construction project, which is designed to enlarge sewer lines in the area to address a long history of chronic flooding.


Moore said the sewage spill, which was pumped out over several hours Sunday night, is under investigation and reports are due to various regulatory agencies.

"It's right at the threshold of requiring a technical report," Moore said. Signs have been posted along the pathway where the spill might have surfaced. Residents are warned not to make contact with any standing water or creek water along the pathway.

"We're notifying the public (that the sewage) went into storm drain gutters and (could have) reached surface waters," Moore said. "We'll be having water quality samples analyzed, and testing bacteria levels in creeks."

The district is in touch with Marin County environmental officials and will file a report Tuesday with the state's regional water quality board, he said. "We have to make diligent review of the facts."

Moore said he expected to post all reports and testing results on the district's website.

"This is very relevant, as we will have more storms coming in," he said. "This is a known area of historical problems, and the project is designed to address those historical problems. We're fixing leaks in the upper system, and making larger pipes in the lower system, but it wasn't completed in time (for Sunday's heavy rains)."

Chuck Plomteaux-Dispatch, spokesman for the sewer project contractors, Maggiora & Ghilotti Inc., declined comment, referring all questions to Moore.

Neighbors said they were not notified when the event occurred and had no word what had happened.

"For the last eight or nine hours, Ross Valley (Sanitary District) has had multiple trucks pumping and leaving and arriving the corner of Broadmoor and Morningside (Drive)," said Karen Dauphin, a San Anselmo resident, in an email late Sunday. "The heavy rain, an electrical outage, and all this pumping where they have been working over the last month or so is quite disturbing."

San Anselmo received 3.73 inches of rain on Sunday and 5.6 inches total over the weekend, said Steven Anderson of the National Weather Service.

"It was the highest rainfall total in Marin," he said of the San Anselmo numbers.

Also Sunday, parts of the Contempo Marin neighborhood in San Rafael were flooded Sunday. Residents at Contempo Marin posted photos on Tw itter showing several inches of water up the front steps of the homes. "The problem with the park is that everything is set to drain into the lagoon," said Contempo Marin resident Sylvia Picone. "When the lagoon is full, there's no place for the water to go."

Picone said none of the high water went inside the homes, but it did go into carports, making it difficult for some residents to get to their cars. Most of the water was gone by Monday morning, she said.

Compounding the flooding problems over the weekend were power outages.

Deanna Contreras, a spokeswoman for Pacific Gas and Electric Co., said 152 customers lost power in the area of Sir Francis Drake Boulevard and Broadmoor Avenue in San Anselmo from 2:25 to 5:45 p.m. Sunday. That was in the same area as the sewage spill.

The cause was listed as "an equipment issue," according to a PG& E notice.

Overall, about 10,000 customers in Marin, Napa and Solano counties lost power over the weekend, including about 6,500 in Marin. Along with the San Anselmo outage on Sunday and two Corte Madera outages over the weekend, there were several momentary outages in Stinson Beach and Tiburon. Power was restored to all customers as of Monday morning, Contreras said.


In San Rafael, a rainfall total of 3.6 inches was recorded on Sunday and 5.1 inches for the weekend. Marin County's totals were among the highest in the Bay Area, Anderson said.

Anderson said the forecast calls for more rain on Tuesday between about 5 and 10 p.m., with totals estimated at between 1 to 2 inches. Temperatures this week will be in the range of 60 degrees for a daytime high, and overnight lows of between the mid-40s and 50 degrees — warmer than last week.

"There's a milder air mass over the Bay Area now, compared to the arctic air mass last week," Anderson said.





How hydropower plant sale could affect Marin

POTTER VALLEY

Deal studied for impacts on water supply, fishery health

Questions remain as to what extent Marin County water supplies will be affected by a potential change in ownership and operation of a 110-year-old hydropower plant more than 100 miles to the north.

"This is a complicated issue and it's just underway," North Marin Water District General Manager Drew Mc-Intyre said.


Pacific Gas and Electric Co. is seeking to auction off its Potter Valley Project hydropower plant, which contains two reservoirs and dams, to a new operator. PG& E cited increasing operation costs, a competitive energy market and lower energy generation needs as reasons for its decision.

The power facility annually diverts an average of about 74,000 acre-feet of water — about 24 billion gallons — from the Eel River through a diversion tunnel in order to generate electricity at its Potter Valley Powerhouse. After passing through a canal and a reservoir at Lake Mendocino, the diverted water is ultimately fed into the eastern branch of the Russian River.

About 75 percent of the North Marin Water District's supply and about 25 percent of the Marin Municipal Water District's supply is obtained from the Russian River. The districts purchase the water from the Sonoma County Water Agency, also known as Sonoma Water.


There are different views on how changes to the Potter Valley Project could impact Marin County's water supplies.

Pamela Jeane, assistant general manager of Sonoma Water, said their agency doesn't track the exact amount of the diverted water that makes its way into their customers' supplies. But Jeane said

any drastic changes to the amount would have impacts to their customers and their ability to meet water flow mandates set by the state to protect the environment.

"This is a big deal," Jeane said. "This could be a really big game changer if something drastic changes with regards to the operation of (the Potter Valley Project)."

Other stakeholders say the risk is minimal, at least for Sonoma Water agency customers.

"From my perspective, there is absolutely no jeopardy to North Marin or Marin Municipal or for that matter the Sonoma County Water Agency's water supply for their customers that has to do with the reliability of the Eel River diversion," said David Keller, the Bay Area director of the environmental organization Friends of the Eel River.

'Cloud of uncertainty'

PG& E's auction announcement in mid-2018 came in the midst of the Potter Valley Project's federal relicensing process, which has drawn keen interest by a large collection of stakeholders. The project's license is set to expire in 2022.

PG& E spokesman Paul Moreno said the request for offers they sent out seeks a new operator that can assume PG& E's responsibilities as the owner and operator of the existing project.

"It will be up to the new owner to determine whether to consider or pursue alternatives to current operations," Moreno wrote in an email.

PG& E set a Feb. 1 deadline for preliminary proposals to be submitted and hopes to begin negotiations in mid- to late 2019, Moreno said.

At the same time, an ad hoc committee of stakeholders led by Rep. Jared Huffman, D-San Rafael, is eyeing this relicensing process as an opportunity to address several longstanding issues that have arisen

since the power facility's construction.

These issues include addressing water supply, preventing impacts to wildlife as well as examining whether any of the power plant's dams and facilities can be removed or altered.

Huffman is pushing for a "two-basin solution" that would "improve the health of the river and the fishery on the Eel River while also respecting the water needs in the Russian River watershed."

Stakeholders in the committee say PG& E's attempts to hand off the project to a new owner is complicating the year's-long work by water districts, farmers, regulatory agencies, environmentalists, tribes and others to find some consensus on potentially litigious conf licts. PG& E is also a member of the ad hoc group.

While a Mendocino County joint powers authority has publicly expressed its intent to purchase the power plant, other applicants are not publicly disclosed by PG& E.

"There will be value in this (committee) continuing its work even though it's under a little bit of a cloud of uncertainty as to who will own the project a year or two from now," Huffman said.

For Sonoma Water, Jeane said the auction process doesn't change the work to find a solution that works for both river basins.

"We're interested in finding as solution regardless of who may own the project tomorrow or 10 years from now," she said.

Prevent conflicts

Huffman said the idea of his committee was to prevent conflicts between agriculture and environmental interests.

The economies of agricultural centers like Potter Valley and other communities north of Healdsburg have come to rely on diverted Eel River water. Environmental groups say the project's dams have closed off hundreds of miles of critical fish habitat and impacted water quality to the detriment of already threatened species on the Eel River.

"I think the purpose of the ad hoc group is to explore a consensus resolution of what could otherwise be literally decades of conflict with tremendous uncertainty for everybody involved," Huffman said.

Scott Greacen, executive director of Friends of the Eel River, said the idea that PG& E is "blamelessly doing what it can to take care of itself" by passing on the project and its structural and environmental problems to another owner is the "polar opposite of corporate responsibility."

Friends of the Eel River has advocated for full removal of the dams, though Greacen said he recognizes that is not going to work politically.

Some of the agencies in Huffman's ad hoc group are also members of a Mendocino County-based joint powers authority known as the Inland Water and Power Commission, which has expressed interest in buying the Potter Valley Project. One of the member agencies, the Potter Valley Irrigation District, sees the project's water supply as holding "immeasurable" value.

Greacen said the commission's interest in the power plant "with all of its attendant risks and damages" is "just asking for a long-term war."

"If they buy the project and try to keep it in place, they are going to have a generation of lasting struggle over this," Greacen said. "... It's kind of frustrating because we do see a solution in sight and it feels like the other people on the other side of the table are running away from it."

Officials from the North Marin Water District and Marin Municipal Water District say they will be monitoring the situation.

"It is a regional issue and it requires a regional solution," McIntyre said. "No one entity is going to be able to resolve this."

Balancing supplies

The Potter Valley Project is an epitome of the complexity of the state's water systems.

Its reservoirs, dams and operations affect everything from agriculture to wildlife to water supplies in communities spanning across four counties and two of the state's larger river basins.

The water supplied to Marin comes at the tail end of this water system. While communities north of Healdsburg rely on Potter Valley Project water that flows into Lake Mendocino, communities to the south like those in Marin also have access to the larger Lake Sonoma reservoir, which is not connected to the project.

While Keller argues the water would be sufficient for customers south of Healdsburg, Jeane said Sonoma Water is also mandated to meet minimum flow requirements in the river and Dry Creek as part of a more than 30-year-old state water board decision. Cutting off Eel River diversions would cause large impact to meet those mandates, Jeane said. The U.S. Army Corps of Engineers manages both Lake Mendocino and Lake Sonoma, which have been used for flood control. That means water is intentionally released from the reservoirs to make room for the winter rains.

Jeane said this system was implemented in the 1950s and has resulted in water being released even when rains weren't as heavy as expected. She referred to one instance in 2013 where the federal agency released about 13,000 acre-feet of water from Lake Mendocino — more than 10 percent of its maximum capacity — in anticipation of what ultimately became a shortlived storm. "So had they held on to that water it would have been a benefit to everybody," Jeane said.


But this winter, the army corps gave approval of a pilot project in which these flood control releases are conditioned on more modern weather forecasting. The modeling and results have been promising, showing both "better flood protection and better water supply reliabil-ity," Jeane said.

This change alone would not be enough to make up for the loss of diversions from the Eel River, she said.

Keller said there is also the added strain of illegal diversions along the upper and middle reaches of the Russian River.

"If those illegal or unpermitted withdrawals were reduced or eliminated, that would allow for much more efficient and much better use of the water in Lake Mendocino and would reduce the demand on the Eel River," Keller said.


MAXIMIZING OPPORTUNITIES OF ANAEROBIC DIGESTION FROM WASTEWATER

The industry has yet to reach the full potential of anaerobic digestion, specifically in biogas utilization and energy production.

The wastewater treatment sector has used both aerobic and anaerobic treatment for many years; therefore, it is not surprising that it is one of the largest generators of biogas from anaerobic digestion in the U.S. The solids from more than 1,200 plants are treated via anaerobic digestion (AD).¹ Despite these impressive figures, the sector has not yet maximized the potential of this technology.

While 48 percent of all wastewater is treated with AD, only 5,127 water resources recovery facilities (WRRF) from nearly 15,000 facilities across the country are listed as producers of biogas or sending materials to other AD plants for treatment.² These tend to be the largest facilities serving large metropolitan areas. It is estimated that only 85 percent of the facilities that are using AD actually utilize the biogas produced, with only 16 percent producing electricity and just 1 percent producing upgraded biomethane for further use.

Benefits of anaerobic digestion

The U.S. Environmental Protection Agency (EPA) stated that the use of AD can help it meet a number of goals including its target to reduce food waste by 50 percent by 2030.³ Some of the strategic EPA policy goals supported by the increased use of AD include:

- Taking action on climate changes capturing and combusting methane via AD reduces greenhouse gas emissions
- Protecting America's waters the anaerobic digestion of sewage sludge from wastewater treatment facilities plays an important role in cost-effective wastewater solids treatment and management at thousands of facilities
- Supporting sustainable development by reducing fossil fuel consumption, producing local sources of energy and conserving scarce resources such as fertilizers and soil amendments
- Reducing pollution by diverting organic wastes from landfill and agriculture

The EPA also indicated that as the AD sector grows, it may provide additional benefits and help deliver cross-agency strategies on food waste and agricultural efficiency, for example.

Anaerobic digestion from wastewater potential

According to the Water Environment Federation (WEF), Hawaii, Washington and California have the highest percentages of WRRFs that process solids through anaerobic digestion, while New Mexico, Illinois, California and Hawaii have the highest percentages of wastewater flow being treated by AD. The most common use of produced biogas is for digester heating (some 48 percent of WRRF anaerobic digestion facilities use gas in this way), and then building heating, power generation or driving process machinery (8 percent), with just 1 percent used for pipeline injection.¹

The National Renewable Energy Laboratory (NREL) suggests the wastewater sector could produce as much as 2.3 million metric tons of biomethane a year.⁴ Other estimates suggest the U.S.'s aging water infrastructure will require an investment of about \$600 billion over the next 20 years if it continues to reliably transport and treat wastewater.⁵ Many older wastewater AD facilities are now in a position to upgrade and take advantage of the latest technology. All of this means is, there is a huge potential to increase energy production from America's wastewater sector.

When the potential codigestion of food waste is considered, the economics of green gas production become even greater. Research at California State University suggests that mixing 25 percent food waste with 75 percent municipal wastewater sludge can increase biogas production by as much as 60 percent compared to digesting sewage alone. With only a fraction of sites currently codigesting other wastes, the potential for the sector to capitalize is significant.

Take the heat

The use of AD for wastewater treatment has traditionally been driven by the treatment needs of the plant rather than the economics of gas production, energy generation or digestate sales. However, even if this remains the key driver for the installation of AD technology at WRRFs, there are other reasons to make any investment in AD as cost-effective or profitable as possible.

In many cases, the economic decision about whether to invest in AD depends on the overall efficiency of the final project. Techniques such as heat recovery using heat exchangers enable a resource — that would otherwise go to waste — to be used to preheat feedstock or digesters to improve gas production efficiency. Equally, this heat can be used for pasteurization and concentration processes, increasing the value of the digestate coproduct produced.

A well-designed system could recover and use 40 percent of the heat produced by a wastewater AD plant. This free heat provides a useful bonus when evaluating any investment in AD, and it is something that potential developers should consider from the beginning of their planning process.

Reps. Napolitano (D-CA) & Huffman (D-CA) Release GAO Report on Benefits of Water Reuse Projects; <u>Rep. Napolitano</u> <u>to Reintroduce Water Recycling Investment and Improvement Act</u> January 15, 2019

(WASHINGTON, DC)—A new Government Accountability Office (GAO) report (<u>https://www.gao.gov/products/GAO-19-110</u>) released today by the expected Chair of the House Transportation and Infrastructure Subcommittee on Water Resources and Environment, Rep. Grace F. Napolitano (D-El Monte), and the expected Chair of the House Natural Resources Subcommittee on Water, Oceans, and Wildlife, Rep. Jared Huffman (D-San Rafael), shines a light on the importance of federal funding for water recycling projects in preparing the arid West for a changing climate and scarce water supplies.

"This GAO report highlights the importance of water recycling to address water supply concerns in the arid West and particularly in my region of Southern California," said Rep. Napolitano. "It further describes the overwhelming demand for the primary water recycling program of the federal government, the Bureau of Reclamation's Title XVI program. Water recycling used to be thought of as an alternative supply option, but the growing reliance and acceptance of this technology has put recycling on par with traditional water sources, such as groundwater wells, aqueducts, and dams. I thank GAO for their comprehensive research and assessment of this technology, and I look forward to working in tandem with Chair Huffman to promote sustainability in addressing all of our water supply needs."

"The Federal government has an important role to play in working with local water managers to modernize America's water infrastructure to meet the needs of a growing population and a changing climate," said Rep. Huffman. "This new GAO report demonstrates the clear benefits of robust investments in water reuse projects that help our cities and rural communities continue to thrive in the face of water scarcity. In the 116th Congress, I look forward to working with Chair Napolitano to expand these proven water solutions that benefit all Americans."

The GAO report released by the two lawmakers, both longtime advocates for sustainable clean water infrastructure, articulates the broad benefits of the Title XVI program, which authorizes federal participation in recycled water projects across the West, and studies covering various uses for reused water. The report identifies nearly a \$1 billion backlog of authorized water recycling projects, demonstrating a clear need to continue and expand Title XVI funding.

For 20 years in Congress, Napolitano has championed water recycling projects in the West and nationwide. She will soon reintroduce her bill, the Water Recycling Investment and Improvement Act, to reauthorize the Title XVI program and increase the funding level to \$500 million to meet the needs of water agencies investing in this technology. As Congress discusses an infrastructure package, the Water, Oceans, & Wildlife Subcommittee will analyze existing authorized programs and how they are meeting public needs, and will work to expand water resilience through sustainable water investments.

Re: Request from 4 Special Districts to Move to Even-Numbered Year Elections

Our office is notifying you, as required by Section 10404 of the Elections Code, that four special districts (Marin City Community Service District, Muir Beach Community Services District, Sleepy Hollow Fire Protection District, and the Tomales Village Community Services District) have submitted resolutions (attached) to the Board of Supervisors to change their regularly scheduled elections for governing board members from odd-numbered years to even-numbered years. The Marin County Elections Department/Registrar of Voters will be advising the Board of Supervisors that it will be able to facilitate the requested changes.

Pursuant to Section 10404 of the Elections Code, the Board of Supervisors is now offering you the option of providing input regarding the effect of the move. However, you are not required to submit input. Comments on the proposed election date changes can be presented at the February 12, 2019 Board of Supervisors' meeting, or written comments may be submitted to the Clerk of the Board, to be received no later than 12:00 p.m. on Monday, February 11, 2019. (Written comments are to be submitted to the Clerk of the Board, Room 329, Marin County Civic Center, San Rafael, CA 94903. The start time of the February 12, 2019 meeting will be posted on Thursday, February 7, and can be viewed on-line at that time at http://www.marincounty.org/depts/bs/meeting-archive or by calling the Clerk of the Board office at 415-473-7331.)



