INTRODUCTION OF PRELIMINARY 2018-19 BUDGET:

McGuire and DeGabriele presented the Preliminary 2018-2019 Revenue, Operation and Maintenance, Reserves, Debt Service and Capital Outlay Budgets. McGuire reported that the budgeted revenue is based on the same number of sanitary sewer units as 2017-18 and a maximum rate of \$898 per unit; noting this as the fourth year of a five year rate increase based on the capital outlay plan adopted by the Board in June 2015. The Board and staff discussed income and expense trends including: personnel costs, insurance, operating, and general and administrative expenses. Debt service amounts were discussed. The Capital Outlay budget contains projects specifically identified in the Five Year plan for 2015/2016 through 2019/2020 plus miscellaneous capital needs that change yearly.

Staff will update the budget and bring it back for further review by the Board on May 24, 2018 after the preliminary calculations for the user charge for 2018-19 are prepared.

The Public Hearing for the Budget and Sewer Service Charge is set for June 14, 2018 at 4:30 p.m.
